<b>Birth Parent Casework Services</b>			
Supportive adoption counseling for expectant mother including adoption preparation, assistance in psychosocial and legal issues surrounding the release, collection and preparation of background genetic and social information, and negotiation of openness agreement. Assistance to expectant mother in developing a hospital plan, emotional support to birth family during the hospital stay, coordination of discharge from hospital. Efforts in locating the putative/legal father, supportive counseling for adoption preparation, assistance with psychosocial and legal issues surrounding the release, collection and preparation of background genetic and social information, negotiation of openness agreement. <b>Post-Placement Training (Not Refundable)</b> - Completed through Adoption Learning Partners – training that focuses specifically on the challenges of adjusting to adoption. <b>Placement Services</b>			
Adoptive Couple and Birth Parent Post Placement Counseling and Support. Facilitating hospital services, coordinating services through hospital social worker, grief counseling, lending emotional support to birth family at the hospital, coordinating discharge from the hospital. Preparation of relinquishment and all required placement reports. Facilitating the relinquishment and signing of documents. ICPC Interstate Services and Post Placement Reports, coordinating with out of state agency and/or attorney to effect the legal court placement and Interstate Compact approval of the movement of a child across state lines. Preparation and filing of adoption petition and related documents, preparation of finalization paperwork, attendance at finalization hearing, and participation in additional court proceedings as necessary. <b>Federal Adoption Tax Credit 2017 \$13,570</b> (Currently you can claim the credit on your federal tax return for the year in which your child's adoption becomes final. This is an important financial benefit because it is a dollar-for-dollar reduction in your tax liability. For more information, see the IRS website or consult with your tax preparer.)		
<b>State Adoption Tax Credit</b> (Check with your tax preparer for deductions you may be eligible for within your state of residence. Contact your state's Department of Revenue or Taxation or your State Adoption Specialist for more information.) (Not available in Utah)		
<b>Employer/Military Adoption Benefits</b> (Find out if your employer offers adoption benefits by contacting your Human Resources Department. Advocating for Adoption Benefits – If your company does not offer adoption benefits, you might consider proposing them. The <i>Adoption and Workplace Initiative</i> , sponsored by the National Adoption Center and the Dave Thomas Foundation for Adoption, has developed materials to help you advocate for adoption benefits in the workplace. Military Subsidies – The US Military will reimburse active-duty personnel for most one-time adoption costs up to <b>\$2,000</b> per child or up to <b>\$5,000</b> per year for qualifying expenses for adoptions arranged by a qualified adoption agency.)
